



Carry Legally in Illinois Course

ZZ Cop’s Gun Room, Sycamore, Illinois will be hosting the approved 8/16 hour **Illinois Conceal Carry Course** on a continual weekend basis beginning November 9 & 10. This class will be provided and instructed by **ZZ Cop’s Gun Room** NRA Certified Firearms Instructors and ILCCW Certified Instructors. The first class will begin Saturday, November 9 at 8:00 am (Phase I) and Sunday, November 10 at 8:00 am (Phase II).

Individuals who have not had previous formal training by a certified instructor or are not a veterans of the armed services with an Honorable Discharge (must provide DD214), must take the entire 16 hour course. For individuals who have a certificate of completion from any formal firearms training by a certified instructor or are service veterans with an Honorable Discharge are credited variable hours as authorized by the state of Illinois (see attached form AC101 for clarification and are only required to take the remainder of hours necessary to complete the course.

Phase I: NRA Basic Pistol Training Program (Approximately 8 hours)

- Learn the basic knowledge, skills and attitude necessary for owning and using a pistol safely.
- Learn the fundamentals of marksmanship and ammunition identification.
- Get firearms and range familiarization.

Phase II: Illinois State CCW Laws and Range Qualification Shoot (Approximately 8 hours)

- All participants must have a current FOID card and must be at least 21 years of age with no criminal history or warrants, and must be mentally stable.

Course fees:

16 hour CCW course (Phase I and Phase II) \$250.00

8 hour CCW course (Phase II only) \$125.00

This information must be verified prior to allowing any credit to be applied to this course; it is therefore important to submit your application at least two weeks prior to the class date. Once this credit is combined with additional training hours provided by the instructor, the approved ILCCF Instructor will certify the full 16 hours requirement has been met.
